(w.r.t Fee Hike in the Academic Session: 2025-26)

Dear Parents,

Greetings of the day !

May we take this opportunity to express our gratefulness to each one of you for your continuous support and co-operation extended over the last eight years in offering an effective educational ambience to the children of this locality. Due to the constant efforts as well as mutual reciprocation and understanding between the school & the parent's community, under the patronage of NTPC, we are able to facilitate our children in bringing laurels in Academics as well as Co-curricular activities. With the persistent efforts of the students and the staff members we are committed to scale greater heights in the new Academic Session-2025-26. At this juncture, while preparing the Annual School Development Plan for the new session in consultation with all the stakeholders of the school, it is our moral duty to update you about the Revised Fee structure for the Session 2025-26. You are aware of the fact that, there is a provision of Fee Enhancement of 15% every year (as mentioned in the Student's Diary-2024-25, under the heading '23.FEESTRUCTURE' printed at page No-51 for all the DAV Schools of Odisha).

However, in line with the recommendations and prolonged deliberations with the members of Parents Teachers Coordination Committee (PTCC) in its meeting held on 29 Jan' 2025 & subsequent approval of the School Management Committee (SMC) in its 14th Meeting held on 30th Jan' 2025 (which has been conveyed through HR Dept. of NTPC Ltd.(TK) vide letter no-9501/HR EW/DAV/02-01 on dated 28th Feb'2025) it has been decided that the Fee Structure for the session 2025-26 (w.e.f. 1st April 2025) will be with a **uniform hike of a Fixed Amount** (which is amounting to 6% of the Existing Fee Structure of NTPC Category) **applicable across all categories (NTPC as well as NON-NTPC) of a particular class**. The amount of hike (in 2025-26) on & above the existing Fee Structure(2024-25) for the respective classes are given below for your prior information & necessary action.
